**5. HARLOW & GILSTON GARDEN TOWN - SPATIAL VISION** 

 At the Parish Council Meeting on Monday 2<sup>nd</sup> July, Members were advised of the above spatial vision consultation which included the consultation on Latton Priory.

Members were advised of the details of the Exhibition together with the deadline for comments which is the **27th July**.
