General Summary 2019/2020

The opening account balances as at 1st April 2019 were as follows:

Unity Current Account: £ 3,945.28 Unity Deposit Account: £ 246,298.27

Total: £250,243.55

The precept for 2019/2020 was £219,256.

The total income for 2019/2020 (excluding precept) was £91,805. This included a payment of £50,000 from Epping Forest District Council as a result of the Government giving itself permission to base a temporary customs facility at North Weald Airfield. These monies have been placed into an Earmarked Reserve. The remaining income came mainly via grant of £1,000 received via the Tesco Groundsworks scheme towards new play equipment at School Green Lane play area, a refund of £4,000 from Storm following damage to pipes at North Weald Allotments, together with Allotment, Parish Hall and Cemetery income. Due to the COVID-19 outbreak, the income from the Parish Hall was lower than expected due to the closure of Hall in March 2020, and a number of cancellations.

Total expenditure for 2019/2020 was £272,654. A full breakdown can be found on the income and expenditure account sheet on page 6 of this report.

VAT Reclaims were completed every quarter, the total VAT Reclaim for 2019/2020 being £19,419.83 (with the last quarter payment being £4,717.33 and not received until April 2020).

The Earmarked Reserves as at 31st March 2020 stood at £236,669.72, with a further £72,565.50 in the General Reserve Fund (totalling £309,235.22 – see page 7 for breakdown as to why this is different from actual Bank Balances)

The current outstanding balance due on the Public Works Loan Board is £10,579.59. It should be noted there three PWLB payments in this financial year, due to the last payment in 2018/2019 not being taken until April 2019.
