4. \square CONFIRMATION OF MINUTES \checkmark

5. \square PLAY AREA INSPECTION REPORT \checkmark

On Friday, 14 June 2013, a quarterly inspection of each play area within the Parish was carried out by Councillors Mulliner, Hawkins and Bartram together with the Finance and Administrative Officer. A copy of the inspection report is attached at *APPENDIX 2*.

With regard to the inspection report, Members of this Committee are asked to *CONSIDER* how they wish to move forward with the following points:-

- a. School Green Lane Play Area *"Rub down, treat and repaint top bas to flat Swing and Cradle Swing. Priority 3".*Despite several requests, this work has still not been completed.
- b. Thornwood Common Play Area "Backfill the pot hole in the grass surface in front of the goal on the Monster Ball Games Wall". Despite several requests, this work has still not been completed.
- c. Thornwood Common Play Area It was noted during the inspection that there were a number of bags filled with dog faeces thrown into the rubbish bin inside the perimeter of the play area.

7. THORNWOOD ALLOTMENTS NATURE AREA

Members of this Committee are asked to *NOTE* that the Clerk has received confirmation from Kevin Mason of Epping Forest Countrycare that they have now completed the work which was being carried out on the Thornwood Allotments Nature Area. The works included diverting the top ditch into the nature reserve and digging out a small pond. Countrycare have created a dead hedge behind the bench and used the spoil from the ditch to create an embankment along the ditch line, which should make the site safe. The hedge on the recreation ground side has been reinstated and made bigger, the recreation ground side has been reinstated and made bigger, the recreation ground side has been cut and raked and any overhanging trees and branches removed, there is now lots of colour from the wildflowers. Countrycare have confirmed that they will cut the whole site later in the year, once the flowers have finished.

8. ■INVITATION TO PARTICIPATE IN THE 2013/14 WINTER SALT BAG PARTNERSHIP SCHEME

The Clerk has received correspondence from Essex County Council inviting the Parish Council to participate in the 2013/14 Winter Salt Bag Partnership Scheme. Essex County Council are looking to support local communities to help themselves during periods of heavy snow and build on community resilience, therefore they would like to make available, to each participating Town and Parish Council, a one tonne wrapped pallet made up of individual 25kg bags for use by the community on the local highway. Essex County Council are offering this free of charge this year. A copy of the invitation is attached at *APPENDIX 3*. Members are asked to *CONSIDER* if they wish to participate in the scheme this year. The Clerk has been asked to respond to Essex County Council by 21st July 2013.
