# 10. ALLOTMENTS

### a) Boundary between Wheelers Farm Gardens Allotment Site and Queens Road Allotment Site

Correspondence has been received regarding the boundary between Wheelers Farm Gardens Allotment Site and Queens Road Allotment Site, a copy of which is attached at **APPENDIX 1**.

#### b) North Weald Allotments

Following a meeting of the Allotment Sub Committee on Wednesday, 16 April 2014, a recommendation has been made to request that the Environmental Committee AGREE to amend Schedule 2(b) of the Allotment Rules and Regulations to read as follows:-

Meeting: ENVIRONMENTAL Date: 11 June 2014

> Use of the entrance into Wheelers Farm Gardens allotment via the High Road is for allotment tenants of Wheelers Farm Gardens only, and should only be used as per official Lighting Up hours. The official definition of Lighting Up hours is one half hour after sunset and one half hour before sunrise. In any case, access via the Wheelers Farm Garden entrance is prohibited before 7am at all times. Allotment holders wishing to gain access to the allotment outside these times are respectfully asked to do so via the Queens Road entrance.

# 11. GREEN OUTSIDE PARADE OF VILLAGE SHOPS, NORTH WEALD



Following the Parish Council Meeting on Monday, 12 May 2014, it was AGREED that the issue of tidying the green area and installing flower beds should be discussed by the Environmental Committee.

With regard to the phone box, arrangements were made for Thornwood Grounds Maintenance to clean this (inside and out) in April (removing all posters) however, it was brought to the Clerk's attention that a poster had since been pasted onto the window. Members are asked to *NOTE* that Thornwood Grounds Maintenance removed the poster in question and cleaned the phone box on 17 May 2014.

# 12. REPLACEMENT BUS SHELTER – TALBOT ROUNDABOUT



- Members are asked to *NOTE* that the Clerk has received confirmation from Essex County Council that the Local Highways Panel have agreed to top up the remaining £5,000 Section 106 monies held by Essex County Council, with a further £3,000 of funding for the replacement of the bus shelter located at the Talbot roundabout. Essex County Council Highways have requested that Members choose two or three preferred designs in order that quotes can be obtained. Information regarding the designs available will be tabled at the meeting.
- b. Councillor Collins is to report on the removal of the old bus shelter and possible relocation to Weald Common.

#### 13. WEALD COMMON PLAY AREA

The Clerk has received correspondence from North Weald Mums Group, confirming that they have been successful in obtaining a grant for the sum of £4,670.60 from the Grange Farm Trust, towards new play area equipment.
