12. LOCAL GOVERNMENT REVIEW OF ELECTORAL BOUNDARIES

At the previous meeting Members were advised that there is to be a review of Electoral Boundaries. This will affect the Epping Forest District in some way and will mean that District Councillors will probably represent approximate 15,000 residents in each area which will include various Parishes. The Clerk is still awaiting further documentation and hopes to have this for the meeting.

15. HASTINGWOOD B ALLOTMENTS

At the last meeting Members Agreed that they would like to reconsider the sale or renting of Hatsingwood B allotment site. Section 8 of the **Allotments** Act 1925 states "Where a local authority has purchased or appropriated **land** for use as **allotments** the local authority shall not **sell**, appropriate, use or dispose of the **land** for any purpose other than use for allotments without the consent of the Secretary of State".

The Clerk has been researching the updated information on Disposal of Allotment Land and will report further at the next meeting. The Updated information is with the Clerk for Members perusal.
