On Tuesday, 7 January 2014, Adriana Jones, the Finance and Administrative Officer, Received the email and letter, attached at **APPENDIX** from LDFconsult@eppingforestdc.gov.uk at Epping Forest District Council. This was forwarded on to the Clerk as nothing was sent to the Parish Council by LDFconsult@eppingforestdc.gov.uk. The Clerk contacted EFDC the following morning to ask why the Parish Council was not sent the letter direct and was advised that it had been sent to Adriana as Deputy Clerk. The Clerk expressed her concern that number one, the Parish Council had not been contacted initially as a primary stakeholder. Number two, the District Council has, yet again, incorrect details as to who to send any consultations to and number three, that they simply presumed that Adriana is Deputy Clerk. Copies of the letter were forwarded to the Clerk later on the Wednesday.

Summer North contacted the Parish Office on Monday, 13 January 2014 and spoke to Jo Tyler, Administrative Officer, to ask how many noticeboards the Parish Council has and to display posters. Jo advised that we had ten noticeboards and that we would put them up this week. With regard to the event in North Weald Village Hall, we have seen sight of an email that confirms flyers will be distributed to North Weald, Thornwood and Hastingwood residents.

d. Tour De France 2014 – Local Authority Planning Group (LAPG)

Communication has been received from Epping Forest District Council regarding a representative for the Tour De France 2014, Local Authority Planning Group (LAPG). The meeting to facilitate this is on Monday, 27 January 2014. This will not be in time to be discussed at the Parish Council Meeting on Monday, 3 February 2014.
