The proposal by its bulk and massing represents an Overdevelopment of the site Policy GB15A refers There would be adverse impact on adjacent listed buildings

Concern about position & sitting of garages

The derelict outbuilding was only ever used a greenhouse for the family and has never been used for commercial purposes

There are problems with sewers with the adjoining houses and they have to have the drains rodded at least 4 times a year

Concern at the large number of car parking spaces needed this could indicate that the proposal is for a commercial and not a residential use

Concern about the way Cubic Metres have been used in the Planning Application to depict the volume of the application as this does not fully represent the footprint or the sizes of the application.
