The Parish Council OBJECTS to this Application due to the concerns in relation to the junction with the B1393. This road carries considerable volumes of traffic and concern has been expressed that vehicles would have to drive into the far side lane when exiting Marlowes.

The junction would not meet the minimum requirement of Highway Standards by the Highway Agency. Therefore this is a Highways Safety Issue. Thereby making the road unsafe for all vehicle use.

The entrance is close to the Garden centre where permission has recently been granted for 16 homes and with a further amount of 124 homes in the Draft Local Plan which would further congest the area.

It goes against Policy GB7A it also affects the openness of the green belt, it is not a necessary addition of the site within the green belt, neither does it 'constitute very special circumstances within the green belt.'
