The meeting Clerk stated that the Parish Clerk had spoken with Epping Forest District Council who had suggested that the Parish Council may want to consider employing a Planning Barrister / Planning Consultant to represent them at this public inquiry. Councillors noted that public inquiries can sometimes be very intimidating, especially if one is cross examined. Councillors noted that the cost of engaging the services of a professional individual such as a Planning consultant could be extremely expensive, running into the tens of thousands of pounds. Cllr Mrs Godwin-Brown asked if all appeals would need to be dealt with by a Planning Consultant, to which the meeting Clerk stated this would not be the case, and that due to these specific applications, it is expected that planning Barristers would be appointed by both the appellant and the local planning authority. Councillors expressed their concern at what the potential cost of a Barrister / Consultant would be and whether or not this would be warranted. Cllr Grigg asked if the members of the public present would be attending the Public Inquiry. The Chairman invited the members of the public present for this agenda item to address the committee. A resident of Hastingwood Road ask for clarification with regard to the Committee's discussions in that did they feel the cost to employ a Barrister / Consultant was too expensive, or was it that they simply did not want to spend the money. The meeting Clerk stated that to-date, the Parish Council has objected in the strongest terms to these applications, however as the Parish Council is only a Statutory Consultee, they are not the responsible body for making the decision, and as such they have a responsibility to consider the amount of money it would cost and if they could justify this to the electorate.

Cllr Godwin-Brown asked if EFDC would be hiring a Barrister for the inquiry, to which Cllr Grigg confirmed they would have Counsel, and stated that having attended inquiries in the past, the Parish should be represented. Cllr Blanks stated that a Barrister would not be less than £500/hour.

After discussion it was *AGREED* that the meeting Clerk should obtain estimate costings of how much it would cost to employ a Barrister / Consultant to represent this Parish Council at the Inquiry, and that this should be on the next agenda for discussion / agreement. The representatives in the public confirmed they would be attending the Inquiry. The meeting Clerk reminded members that a written response would need to go to the Planning Inspectorate by 23rd March 2016,

Councillors noted that notification of an appeal reference EPF/215/15 had been received however this would be on the next agenda.

### b) Essex County Council Consultation

Proposal for Strategic Development (transportation) and Community Infrastructure Pre-application Advice and Developer Contribution Enquiry Charges

The Clerk has received correspondence from Essex County Council, seeking views on the proposal to introduce charging for pre-application advice and developer contribution enquiries on Strategic Development (transportation) and Community Infrastructure.

The Clerk attended a Parish Council Engagement Event held at Chelmsford on Tuesday, 1 March 2016, where it was confirmed that the site at Hastingwood had been removed, and no further allocated sites were near to this Parish.
